PAYMENT TERMS: Client agrees upon total fee of \$ _____.
The initial DEPOSIT IS NON-REFUNDABLE. A minimum of \$250 is required for the deposit. 50% of the total cost is due 60 days prior to the event. To confirm this agreement, return one signed and completed copy along with payment of deposit. All checks and money orders can be made payable to **Bosco Productions**. A \$25 processing fee will be charged for any returned checks.
Gratuities given to the Disc Jockey at an event are made at the sole discretion of the client and greatly appreciated.
OVERTIME: Overtime requested, will be accommodated at an additional \$250 per each additional hour(s) after scheduled events end. Payment for overtime is due no later than events end, and made payable by cash or check to **Bosco Productions**.
CANCELLATION: This agreement cannot be canceled or modified except in writing by either the Client or Bosco Productions. If, client initiates cancellation, under any circumstance, other than a force majeure, then the deposit will be forfeited. Rescheduling for events postponed due to inclement weather or otherwise shall be accommodated when ever possible. Rescheduled events are subject to availability of Bosco Productions calendar.
STIPULATION: If, Bosco Productions breach this agreement by failing to provide the service contracted for this agreement for reason other than a force majeure event, then the client shall recover actual damages that are the result of such breach, subject to mitigation as required by law.
ENTERTAINER'S STIPULATION: Clients shall provide food and beverage served at venue to DJ's at a designated table.

PROVISIONS

The Client shall ensure that: (1) performance facility provides DJ with a sturdy covered table approximately 2x8 feet in an area within 25 feet of a 110-volt outlet (3 prong grounded); (2) facility is open one hour prior to scheduled time; (3) facility meets all state and federal safety regulations and has all appropriate music licenses and performance permits; (4) reasonable steps will be taken to protect the DJ's equipment, personnel, and music, and crowd control will be provided if warranted; (5) for outdoor performances, appropriate shelter will be provided that completely covers the DJ's equipment from any weather conditions.

Client accepts full responsibility and is liable for any damages, injuries, or delays that occur as a result of failure to comply with these provisions. In the event of a threatening situation to create harm to the DJ, equipment, by any person(s) whether sober or intoxicated, the DJ reserves the right to stop play of music or performance thereof. Client is responsible to resolve any threatening situation. DJ reserves the right to deny any access to equipment or recordings. In the unlikely event the DJ's performance is delayed, liability is limited to providing Client with performance time equal to time lost.
